All models are required to go through our terms and conditions carefully and agree to them after which they will be considered as a model under Anima Models and sent for assignments and projects.

- a. The agreement between models will be signed for 1 year which is divided into four quarters; we will be providing auditions & assignment opportunities for each quarter (minimum of 1 assignment per quarter of minimum value Rs. 6,000 (after deducting our charges). The upper limit can vary depending on assignment. Each assignment opportunity that we send will be documented by us via email.
- b. The agreement stands void if Model is selected for an assignment and is required for client visit which she fails to do.
- c. Model changes her contact details and does not inform us and we are subsequently unable to reach him / her.
- d. In return of the above, we as an agency will be exclusively marketing the models for our assignments which will vary from
 - I. Print Shoots
 - II. Commercials
 - III. Brand Endorsements
 - IV. Product Launches
 - V. Events
 - VI. Auditions for films (Indian Hindi, Regional & International)
- e. Models can take assignments from other agencies as well but it is required that the assignment material (i.e. shoot pictures and videos be sent to us whenever they do so to be added to their profile.)
- f. Models who are registered with us need to be comfortable with all types of wear

 - c. Swimwear & Bikini
- g. Punctual at all shoots and events. If model fails to be punctual at shoots without a valid reason we will not provide any further assignments to him / her
